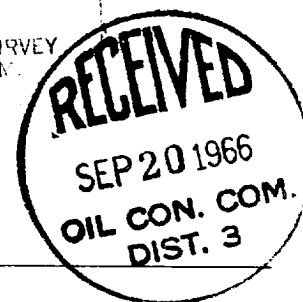
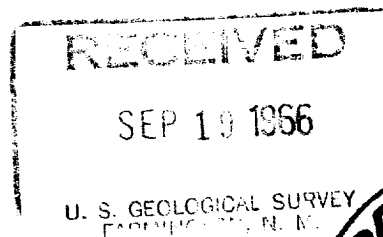

Instructions
