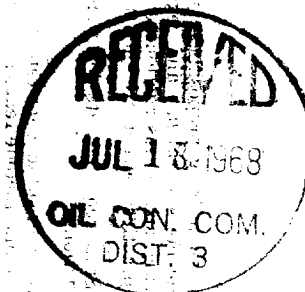

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements for operations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
