Spudded 11-24-63. Drilled 12 1/4" hole to 33'. Set 33' of 9 5/8" casing and cemented to surface with 14 sacks cement. MOC. Drilled sand, shale, bentonite, and limestone to 978'. Ran 32 joints 5 1/2" casing, landed at 978' and cemented with 100 sacks cement mixed with 100 sacks Diamix followed by 50 sacks neat. Good returns. Ran Schlumberger neutron log 12-8-63. Perforated 2 jets per foot 884'-894'. Sandflooded with 10,000# sand, 500# "ADMIX-AQUA" additive, and 10,000 gallons water. Ran 27 joints of 2 7/8" tubing, landed at 840'. Ran rods and plunger. Released rig 12-9-63. Moving out cable tools.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
