13. Describe Proposed or Completed Operations

1. Pull 1 1/4" tubing.
2. Clean out (drill out) from 2,095' - 2,230'.
3. Run OH log.
4. Run 2-7/8" casing to new TD and cement to surface w/ 272.1 cu.ft. of cement.  
Lead: 114 skx Class "B/G" w/ 2% sodium metasilicate, 5 pps gilsonite, ¼ pps cellophane. Tail: 25 sks Class "B/G" w/ 1% sodium metasilicate, 5 pps gilsonite, ¼ pps cellophane.
5. Selectively perforate, acidize, and foam fracture Pictured Cliffs formation.
6. Clean out well.
7. Run 1-1/2" tubing. Return well to production.

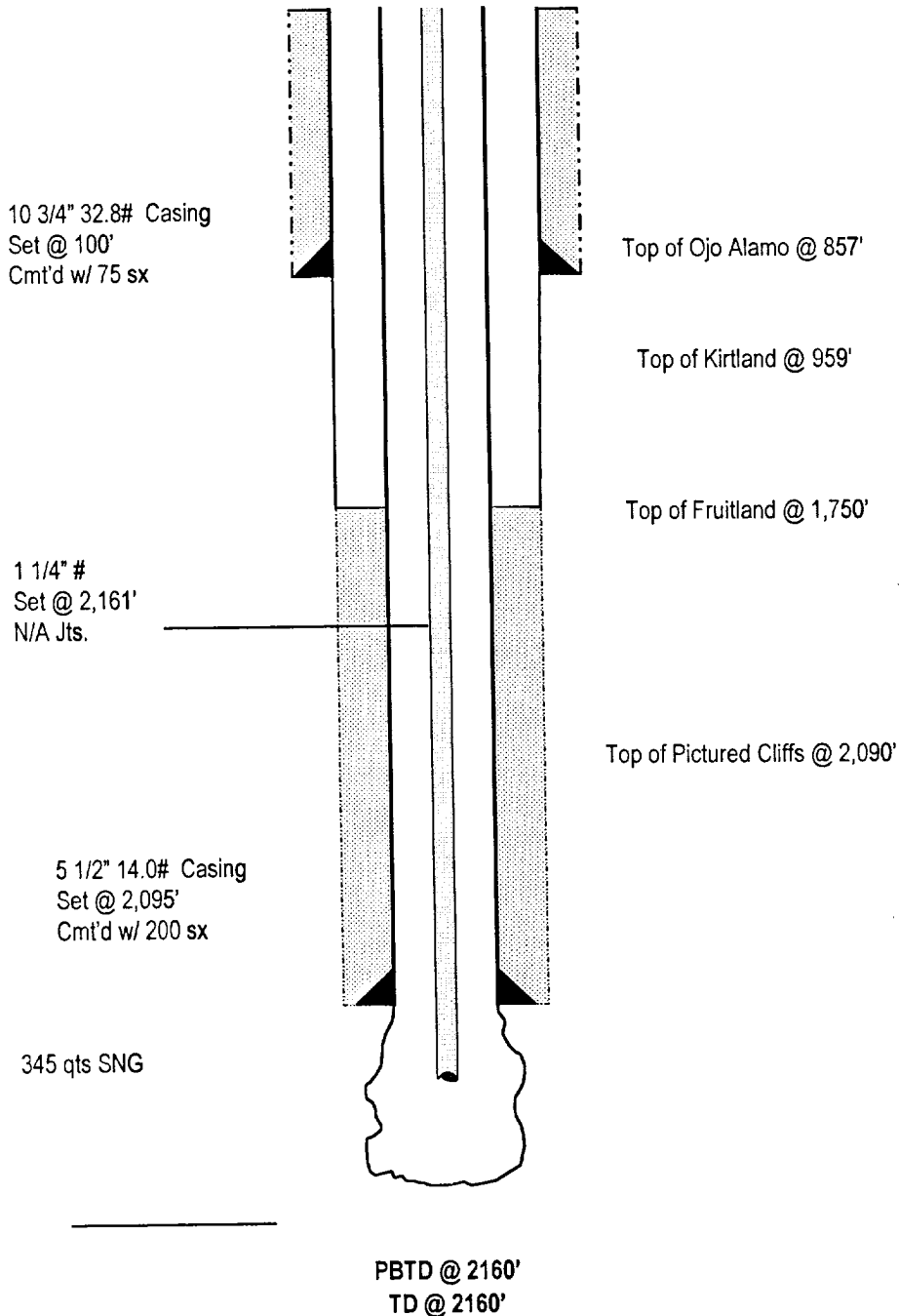
