The Cornell #1 was plugged in the following manner:

June 14, 1984: Moved on location and rigged up.

June 15: Layed down 1" tubing and picked up 1 1/4" workstring. Spotted a 55 sx (64.9 cu.ft.) cement plug in the open hole section to fill from 1950' to 1510'. Covering both the Fruitland and Pictured Cliffs formation. WOC 6 hours. Tagged cement @1515'. Cement was still green. Perforated 4 squeeze holes @750', 50 below the bottom of the Ojo Alamo formation.

June 18: Circulated out the bradenhead from 750'. Spotted a 70 sx (82.6 cu.ft.) cement plug. Pressure displace 37 sx (43.7 cu.ft.) into the perforations. Leaving a cement plug inside and outside the casing from 500' to 750' covering the Ojo Alamo formation. W.O.C. 6 hours. Tagged cement @475'. Perforated 4 squeeze holes @150', 50' below the base of the surface pipe. Circulated a 50 sx (59 cu.ft.) cement plug back to the surface, leaving the casing full. Cut off wellhead an installed dry hole marker with 8 sx (9.44 cu.ft.) cement.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
