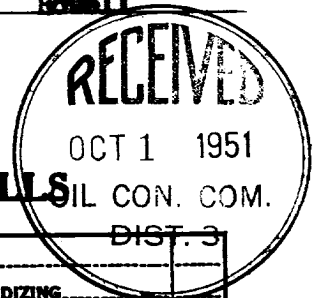

DETAILS OF WORK

It is intended to drill a well with rotary tools through the Mesaverde section, drilling the pay sands with gas circulation; and to shoot the entire Mesaverde with approximately two quarts of S.N.G. per foot.

Casing Program As Follows:

9-5/8" at 300' with cement circulated to surface.
7 " at 4332' with 300 sacks cement.

W/ 320 acres of Section 22 dedicated to this well.
