DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was drilled to TD 4200' using mud.  
Ran 4190' of 7" 20# J-55 S 3 casing landed at 4200' with 200 sacks of cement. Casing was pressured to 800# for 30 minutes with no drop in pressure. After cement set plug was drilled and hole blown dry with gas and remained dry. Drilling was resumed to TD of 4908'.
