This well was spudded on September 26, 1955. On September 27, 1955, 10-3/4" casing was landed at 262' and cemented with 245 sacks. After waiting on cement 36 hours casing and water shut off were tested with 500# for 30 minutes with no drop in pressure. Drilling operations were resumed.
