 7" at 4770' with 900 sacks of regular cement.

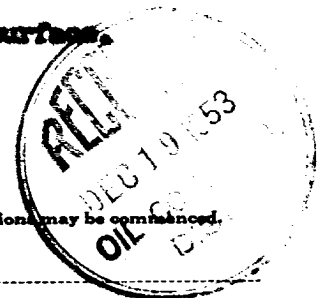
The E/2 of Section 11 is dedicated to this well.
