Spud 4-22-66, drill with rotary to 127. Ran 3 joints 8 5/8" 20# & 24# J-55 casing, 8R, set at 127. Cemented with 100 sacks. Recemented with 50 SX down outside of casing. WOC. Tested casing to 500#psi, held okay. Drilled cement & drilled to TD-2224'. Ran welex GR-Density log. Ran 81 joints 3 1/2" 9.2# 10R casing set at 2219. Cemented with 250 SX. Cement circulated. WOC. Released rig 4-25-66. Now waiting on completion rig.
