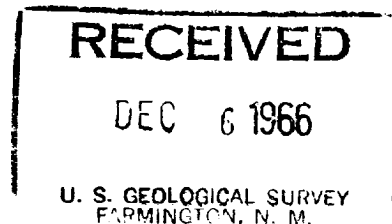

11-30-66 T. D. 5768'. Ran 76 joints 4 1/2", 10.9#, J-55 liner (3914') set from 2454' to 5768' w/250 sacks cement. W.O.C. 18 hours. Tested w/1500#/30 min. O. K.
12-2-66 Perf. Point Lookout 5422-34, 5344-5348' w/16 SPZ, frac w/34,000# 20/40 sand, 34,000 gallons of water. SEP 3400#, tr. pr. 1400-1800-2700#. I.R. 60-6 BPM.
Dropped 1 set of 16 balls, flushed w/7500 gal. water. ISIP -0-. Set bridge plug at 5015', tested w/3500# O. K. Perf. Cliff House 4951-55', 4968-66', 4979-83', 4990-94' w/16 SPZ, frac w/36,000# 20/40 sand, 36,420 gal. water. SEP 1400#, tr. pr. 1600-2000-2200#. I.R. 66 BPM. Dropped 3 sets of 16 balls each, flushed w/1 6720 gallons of water. ISIP -0-.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
