DETAILS OF WORK

Dakota test. W/2 of Section 8 (320 acres) dedicated to this well.
Casing program: 300 ft. 8-5/8" casing - 200 sacks cement, circulated to surface.
15.5# - 5-1/2" J-55 casing to be set on bottom, expected
at 6600 feet - cemented with 200 sacks cement.
Two stage tool will be used to protect Pictured Cliffs - with 100 sacks of cement.
Similar protection will be provided with 200 sacks if logs indicate Mesa Verde formation is present, and protection needed.
If commercial well indicated, formation will be
sand water fractured - and 2-7/8" ex E.U.E. tubing set about 20 feet off bottom.

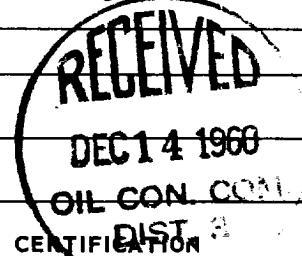

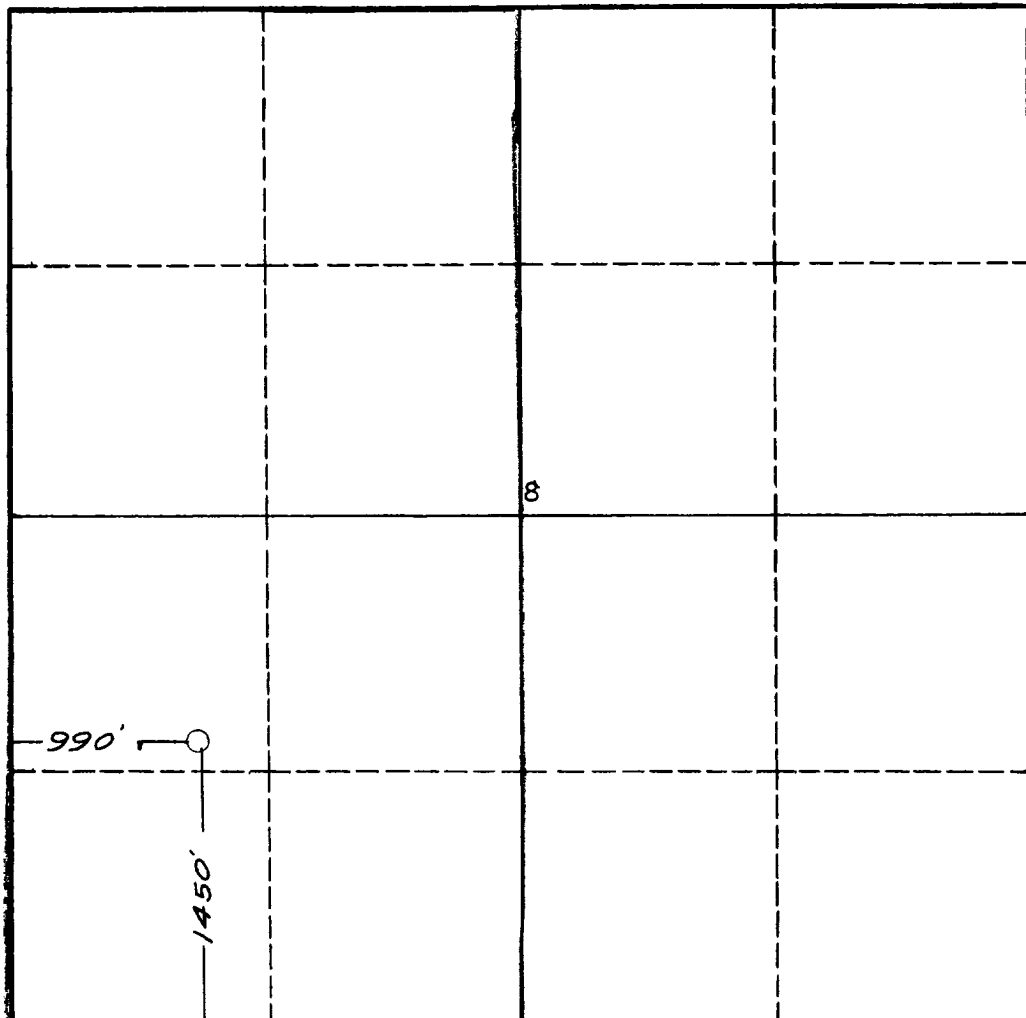
