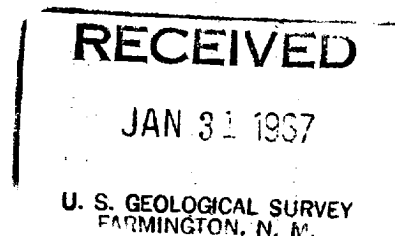

Well was plugged and abandoned as follows:

Spotted 90 sack cement plug from 775' to 875' and 40 sack plug from 298 to 345' in bottom of 16" casing. Plug in bottom of 16" casing did not hold. Spotted 50 sack cement (with 3% calcium chloride) plug from 286' to 345'. Did not hold. Spotted 50 sack cement (with 3% calcium chloride and heated water) plug from 286' to 345'. Cut off wellhead and spotted 10 sack cement plug in top of hole with a 4" pipe marker extending 4' above ground level.
