- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the proposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

IT IS THEREFORE ORDERED:

That the applicant herein, Pan American Petroleum Corporation, be and the same is hereby authorized to dually complete its Martinez Gas Com. "G" Well No. 1, located in Unit A of Section 24, Township 29 North, Range 10 West, NMPM, San Juan County, New Mexico, in such a manner as to produce gas from the Blanco-Mesa-verde Pool and the Basin-Dakota Pool through parallel strings of tubing.

PROVIDED HOWEVER, That applicant shall complete, operate, and produce said well in accordance with the provisions of Rule 112-A.

PROVIDED FURTHER, That applicant shall take packer-leakage tests upon completion and annually thereafter during the Annual Deliverability Test Period for the Basin-Dakota Pool.

IT IS FURTHER ORDERED:

That jurisdiction of this cause is hereby retained for the entry of such further orders as the Commission may deem necessary.

FROVIDED FURTHER, That applicant shall take packer-leakage fests upon completion and annually thereafter during the Annual Deliverability Test Period for the Basin-Dakota Pool.

That jurisdiction of this cause is hereby retained for the entry of such further orders as the Commission may deem necessary.
