- 1) Circulated hole with mud.
 - 2) Trip in with Baker cement retainer, and set at 2990.15. (Unable to set below this point due to bad casing.)
 - 3) Pressure test tubing to 1000 PS. Held ok.
 - 4) Displaced 590 sk of cement below retainer and tested to 500 psi. Held ok.
 - 5) Spot a 10 sk plug on top of the retainer.
- 6-17-85
- 1) Spot a plug from 1520' to 1620' to cover the P.C. formation.
 - 2) Perforate the casing at 1330' and squeeze cement to 1230'. Spot a plug from 1330' to 1230' inside the casing to cover the Fruitland formation.
 - 3) Perforate the casing at 315 ft. Circulate cement to the surface leaving the casing and annulus full.
 - 4) Cut off the wellhead and set a dry hole marker.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
