This well was plugged and abandoned in the following manner:

1. Killed well, pulled tbg. and removed gas lift valves = re-ran tbg. and spotted 30 sx. cement plug 5950' - 5650'.
2. Shot csg. off at free point of 1200'.
3. Spotted 60 sx. cement plug across csg. stub 1200' - 1000'.
4. Spotted 40 sx. cement plug in bottom of surface csg.
5. Installed dry hole marker and cleaned up location.
