On April 21, 1968, the Gallup perfor (4979-4986') were spaced with 20 sacks of Class "C" Best cement. Pressured casing to 2000 psi and OK. The MWD was perforated 3355-3365 with 4 SWF. 250 gallons of 15% regular acid was squeezed into the perfor. It was sand-water fracked with 20,000 gallons water containing 0.5% HCl and 20,000 pounds of 10-20 sand on April 22, 1968.
