As a result of the Wood Oil Com No. 1 ceasing to produce, we plugged and abandoned the well as follows:

1. Spotted 40 sacks cement plug from 4735' (PBD) to 4126'.
2. Spotted 70 sacks cement plug from 3400' to 2100'.
3. Spotted 10 sacks cement plug from 1200' to 1100'.
4. Spotted 5 sacks cement plug from surface to 50'.
5. Pumped 50 sacks cement into 8-5/8" - 4-1/2" casing annulus.
6. Cut off wellhead, erected PXA marker and cleaned up location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated on Federal and Indian lands pursuant to applicable Federal law and regulations, and if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
