DETAILS OF WORK

Navajo Tribal Well No. 3 - Spudded 11:00 hrs August 3, 1960 and drilled to 217'. Set 2-5/8" casing at 217' with 110 sacks cement with 2 percent sodium chlorate. Circulated 25 sacks of cement. After waiting on cement, tested 2-5/8" casing with 400 psi for 30 minutes, which held with no indication of pressure drop. Reduced hole to 1-7/8" at 217' and resumed drilling operations.
