On 03/12/2001, BP America Production Company (formerly Amoco) submitted for your approval a Sundry Notice requesting permission to maintain the subject well in a shut-in status pending review of the well for potential repair to restore well to production status. It was our intention to complete the well review work to determine if an attempt could be made to restore it back to production status either in the existing zone or uphole and avoid premature abandonment of possible reserves by the end of the 4th quarter of year 2001 for all wells in the San Juan Basin. Please be advised that we have not concluded the well review on the subject well and therefore request permission to maintain the subject well in a shut-in status pending the completion of the review. If review indicates no potential exist for this well we will submit plugging procedure for your approval.
