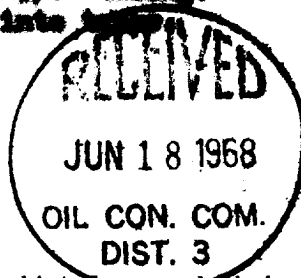

7. Complete open hole - turn into hole.

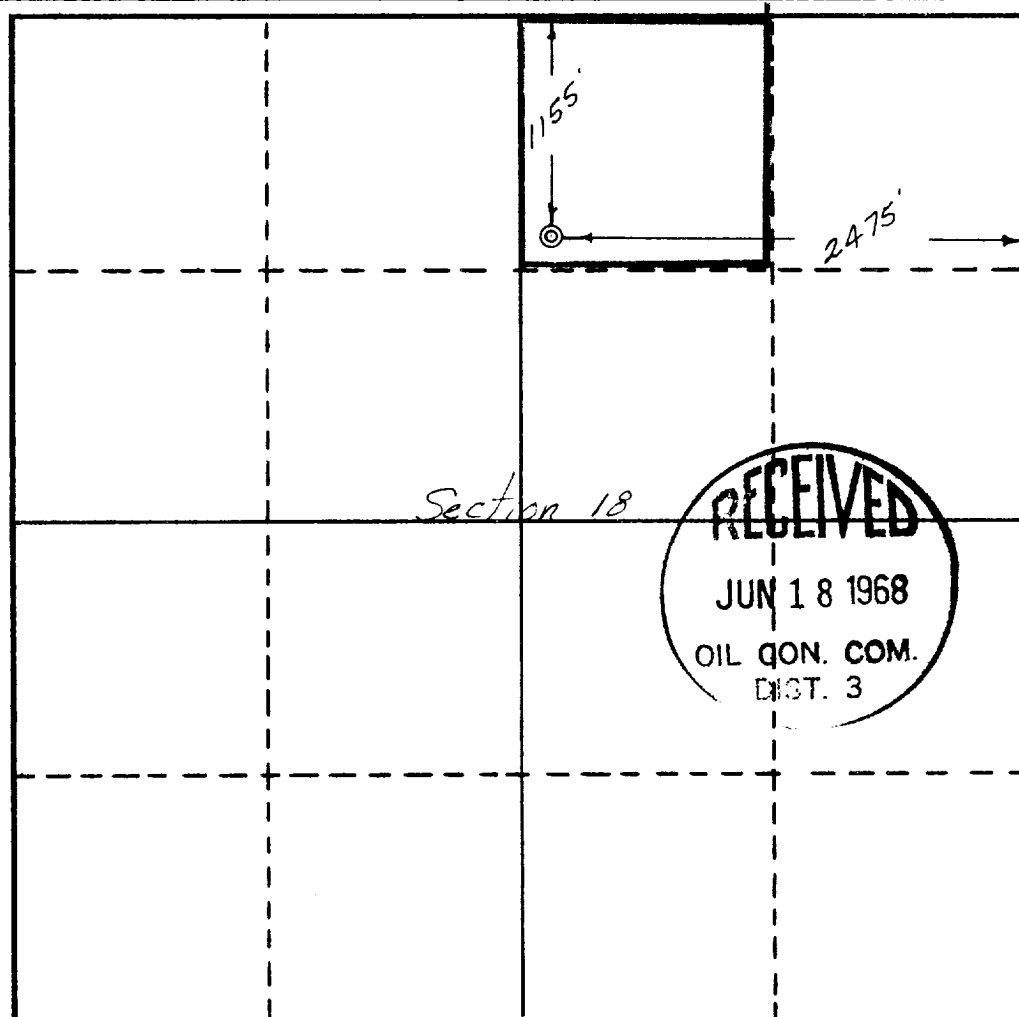
