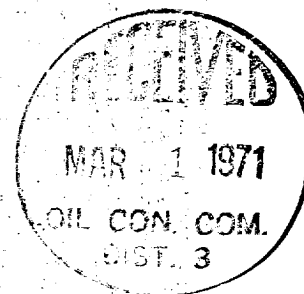

Top of Dakota ss @ 695'. Drilled to total depth of 706'.

Set 4½" casing @ 695' with 15 sax. Attempts to produce were
unsuccessful - formation too tight. Will recover as much 4½"
as possible and will plug 706-606 with 16 sax cement. Will
plug surface with cement 10'-0' and erect 4'4" steel marker
with legal data attached. Will level location and cover pits.
