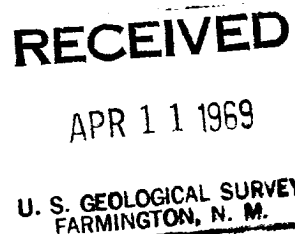

Instructions

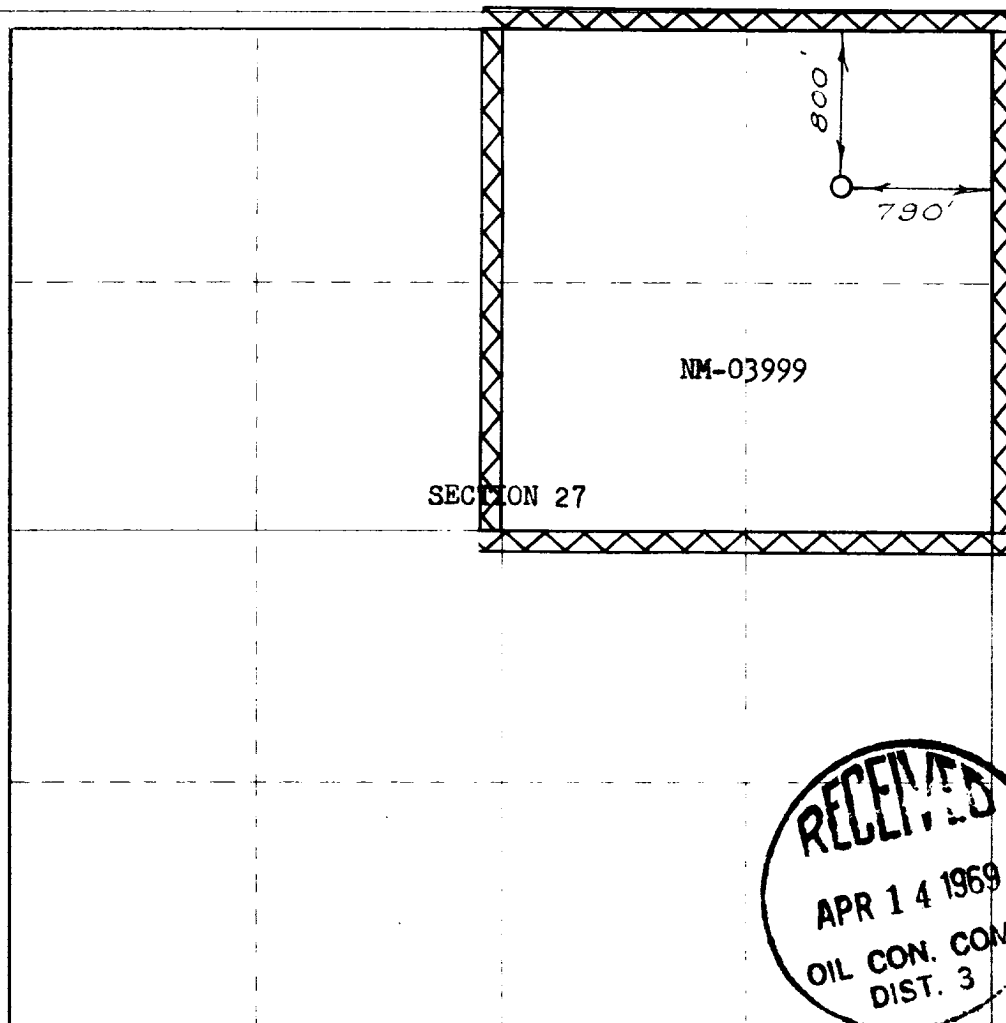

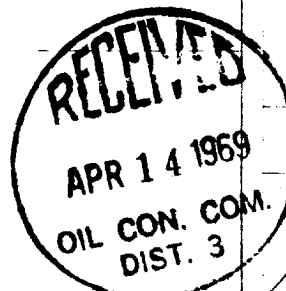
