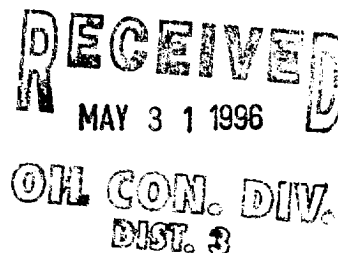

Dear Mike:

Elm Ridge Resources, Inc. wishes to request administrative approval for a Non-Standard Location for the above referenced well. We have purchased the well from the original operator, General Minerals Corporation. The well was originally produced from the Pictured Cliffs formation until economic limit was reached. The well was originally drilled in a non standard location due to topography, the eastern edge of the location is a 400-500' vertical drop into a ravine. General Minerals indicated that they had been granted a non-standard location for the Basin Fruitland Coal at this location and had set a permanent cast iron bridge plug with cement on top to isolate the Pictured Cliffs. They then perforated the Fruitland Coal and ran out of money. Elm Ridge Resources purchased the property from General Minerals and proceeded to fracture stimulate the Fruitland Coal. When submitting the C-104 to the local office of the OCD, it was brought to our attention that there was no non-standard location approval on record anywhere. Hence, the need for this application.

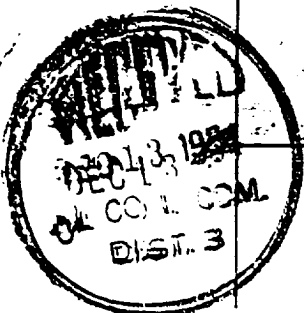
