In an endeavor to clarify multiple issues, please be advised of the following:

Our records do not indicate a change of operator from Eastern Petroleum to Chuska Energy, subsequently Harken Southwest (HSW). However, there is a sundry submitted w/Chuska as the operator in 4/89. Henceforth, Harken Southwest Corporation will submit Monthly Report of Operations (MRO) on the subject well, and all MRO's from 8/89 to present will be amended to reflect the 202 well.

Also, some well records reflect the correct well name as Navajo 202, others call the same wellbore with the same legal description as the Rattlesnake 202. HSW prefers the name of Rattlesnake 202.

In addition, this well is currently maintains a status of Shut-in. HSW has no plans to change the current well status in the immediate future.

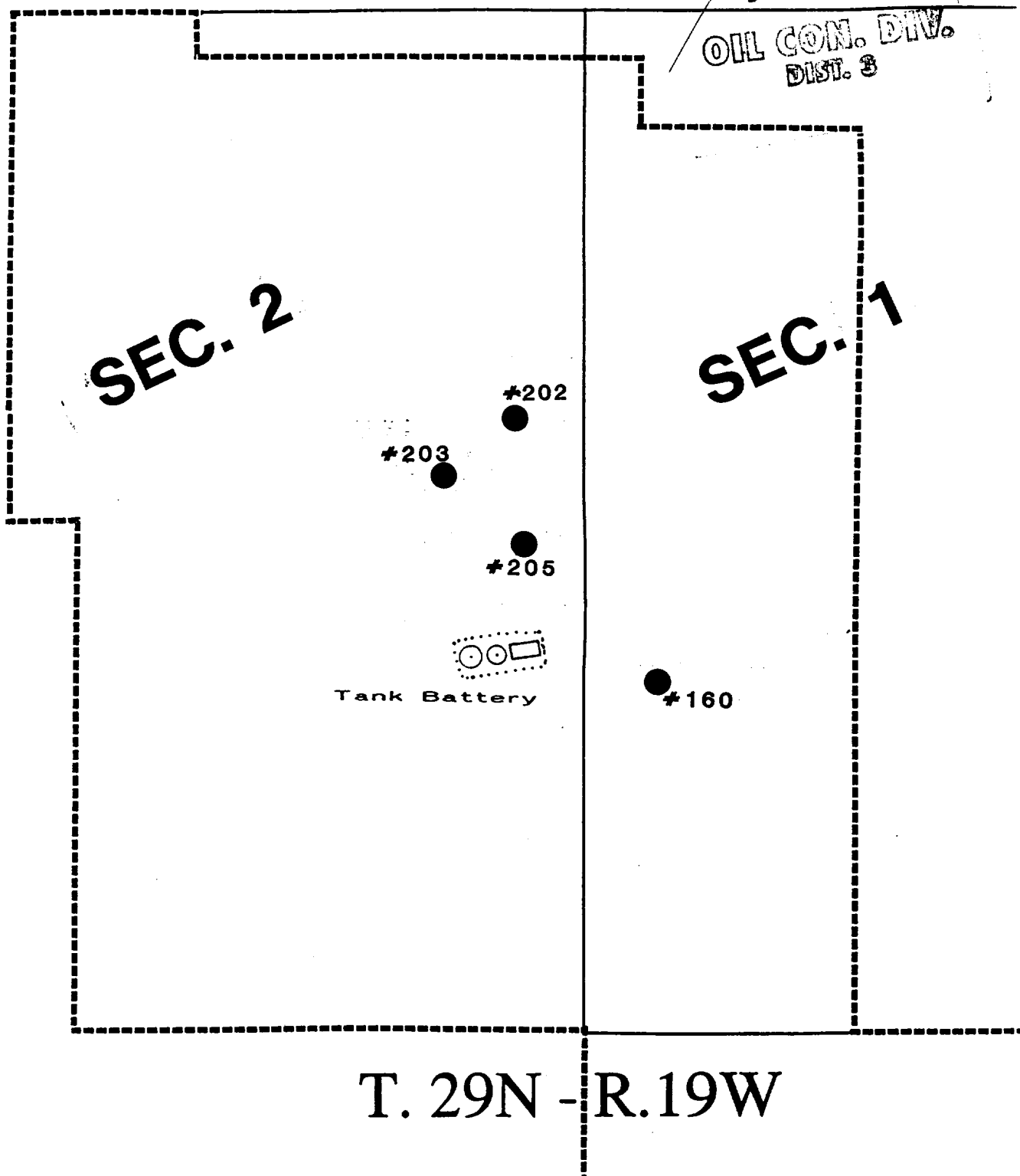
