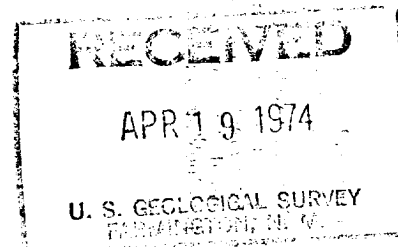

4-18-74 Tested casing to 4000#-OK.
PBTD 1930'. Perf'd 1798-1810', 1818-1828' with 12 shots per zone. Frac'd with 22,000# 10/20 sand and 22,620 gallons treated water. Dropped one set of 12 balls. Flushed with 462 gallons water.
