3. Run 4-1/2" casing and cement to surface with 75 sacks cement.
4. Drill 3-7/8" hole below 4-1/2" casing to approximately 710'.
5. Complete well in open hole without stimulation of Dakota sand.
6. Run 2-3/8" tubing to 700'.

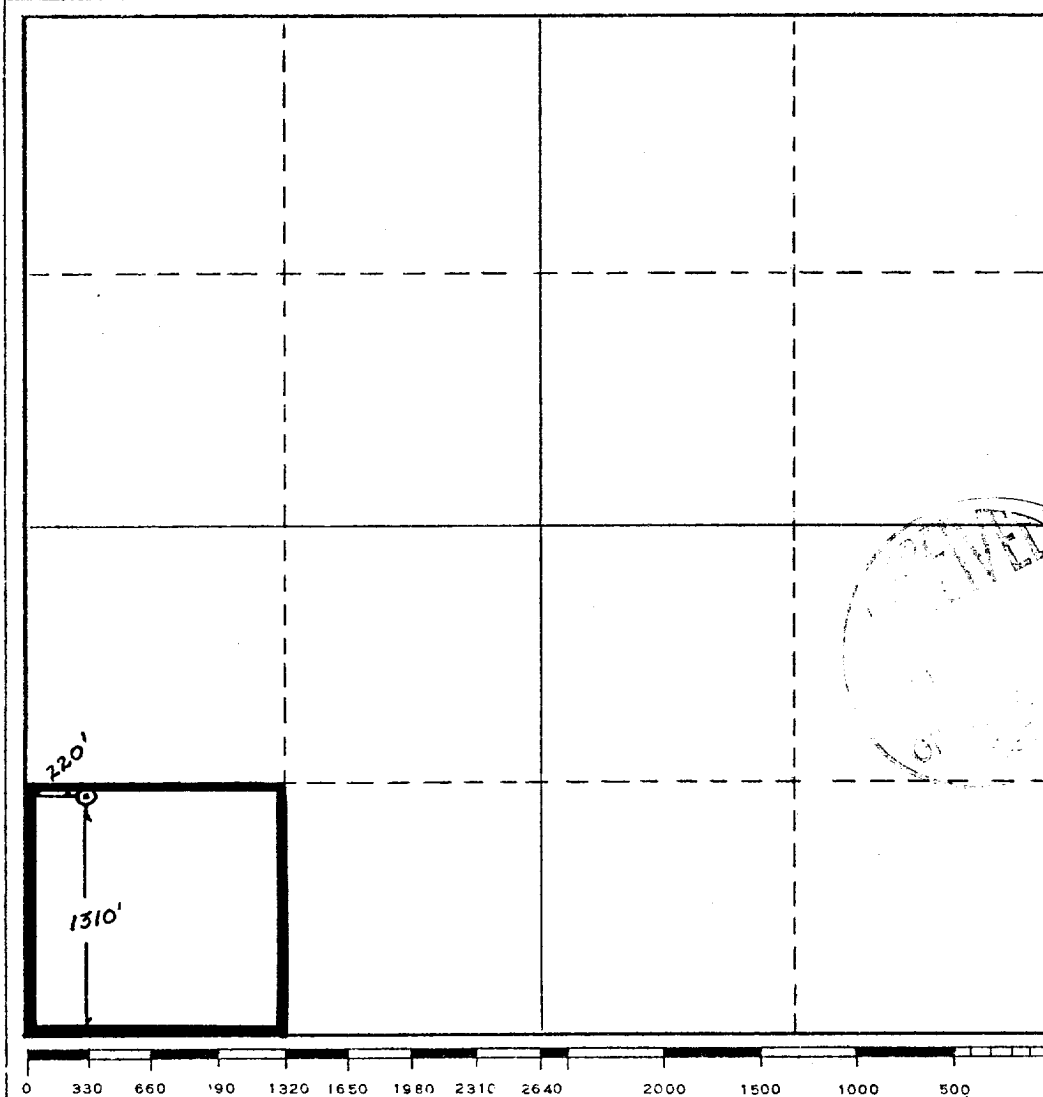
