DETAILED PROCEDURE

1. MIRUSU. Kill w/1% KCl if necessary. NDWH, NUBOPE.
2. RIH w/2-3/8" tbg & tag bottom. CO to PBTD if necessary w/foam. POOH.
3. Set Model D pkr w/expendable plug @ ± 4200 . PT to 500 PSI.
4. RIH w/fullbore pkr & isolate leak.
5. Spot 2 sx sd on Model D.
6. Set pkr ~~10 BBL~~ ^{+6g} above top of leak.
7. Squeeze leak w/150 sxs Class "B" cmt w/6-1/4#/sx gilsonite ^{+2% CaCl.}
8. Overdisplace by 5 BW & resqueeze if necessary.
9. POOH w/pkr.
10. DO cmt & PT to 500 psi.
11. RIH w/~~11.25 to 5.10~~ ^{+6g}, seal assembly, F nipple on 2-3/8" tbg.
12. Circulate hole w/1% KCl wtr treated w/corrosion inhibitor.
13. Land tbg in pkr.
14. Swab well in.
15. Flow to cleanup & test.
