This is to request an extension of approval for drilling, as the approval expires November 19, 1979. Our plans call for drilling this well in the near future.

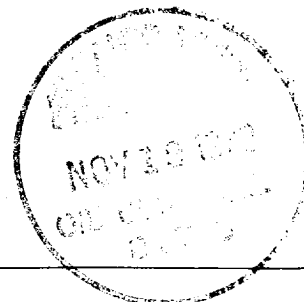
