Perforated intervals of 6310' to 6322', 6327-6344', 6372-6381', and 6400-6404' with 2 SPF, total of 84 holes at .4" diameter.
Sand-water fraced 6310' to 6404' with 105,000 gallons of frac fluid and 262,500# of sand.
Landed 2-3/8" tubing at 6403'.
Swabbed the well and released the rig on 1-22-80.
