Application for Right to Produce Basin Dakota Gas from Six (6) Gallegos Canyon Unit Wells at Unorthodox Well Locations, San Juan County, New Mexico

By this verified application submitted in triplicate, Amoco, Unit Operator of the Gallegos Canyon Unit with a 51.7 percent working interest, requests approval to produce gas from the Basin Dakota formation in the following six (6) Gallegos Canyon Unit wells, each is a Basin Dakota infill well, at the unorthodox locations shown below:

A Form C-107 showing the reason for each unorthodox location is enclosed. Each location is an exception because the permissible location for a Basin Dakota infill well must be at least 790' from the outer boundary line of the undrilled quarter section of the 320-acre proration unit, and be at least 130' from any quarter quarter section line or subdivision inner boundary.

As shown on both the Verification and Affidavit that is a part of this application and the enclosed plat, there are no offset operators to notify because each of the above six (6) unorthodox locations is offset by other Gallegos Canyon Unit wells completed in the Basin Dakota pool.
