

**AFFIDAVIT OF NON-DEVELOPMENT,  
NON-PRODUCTION, AND NON-PAYMENT OF ROYALTIES**

STATE OF VIRGINIA )  
COUNTY OF Fairfax ) ss.

EVELYN B. NIELSEN and GORDON P. NIELSEN, her spouse, whose address is P. O. Box 1014, Springfield, VA 22151, of lawful age, an upon being first duly sworn on their oath, state as follows:

That they are familiar with the lands described in the Oil and Gas Lease dated June 28, 1980 between Evelyn Brimhall Nielsen, "Lessor", and S & I Oil Company, "Lessee", which Lease was filed in Book 899, Page 127 of the records of San Juan County, State of New Mexico on January 27, 1981, and covers the following described lands and formations located in San Juan County, New Mexico:

Township 29 North, Range 15 West, N.M.P.M.  
Section 3: SE/4 SE/4  
Containing 40 acres, more or less  
Limited from the surface down to a depth of  
6,500 feet and no deeper

That for at least 5 years preceding the date of the above-described Oil and Gas Lease and continuing to the present time, the Affiants have been familiar with the conditions, circumstances, and happenings concerning, affecting, and surrounding the production of oil, gas, and associated hydrocarbons or lack of such production on these lands.

That Affiants see the lands frequently and they know of their own personal knowledge, information, and observation that since January, 1991 no oil, gas, and associated hydrocarbons have been produced nor is there any shut-in well located on any part of these lands; and that no development nor drilling operations for oil, gas, and

associated hydrocarbons have been or are being prosecuted upon these lands since January, 1991.

Affiants state that no royalty payments have been paid, tendered, or received by them since August 11, 1991. This last royalty payment covered the production months of July through December, 1990. Affiants also state they have not at any time executed any extensions of the above-described Oil and Gas Lease.

The Affiants state that, based upon their own personal knowledge, information, and observation, any and all oil and gas leases covering these lands are now expired, forfeited, cancelled, or terminated; and that no conditions, circumstances or events exist or have occurred which would have allowed any prior oil and gas leases to continue to be in force and effect at this time. Affiants state they will not by acceptance of any royalty payment or in any other manner recognize any oil and gas leases as valid or existing leases.
