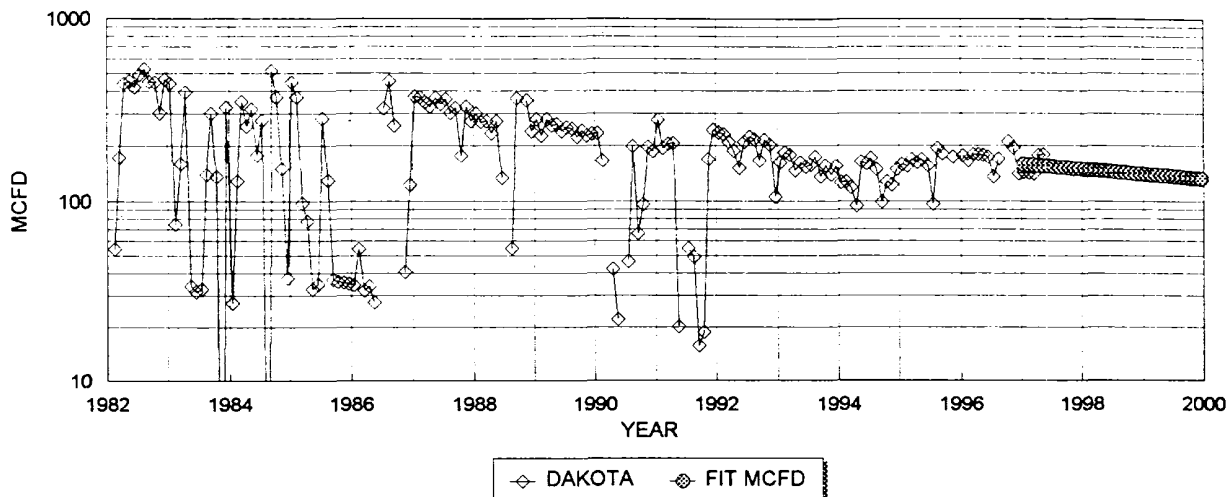

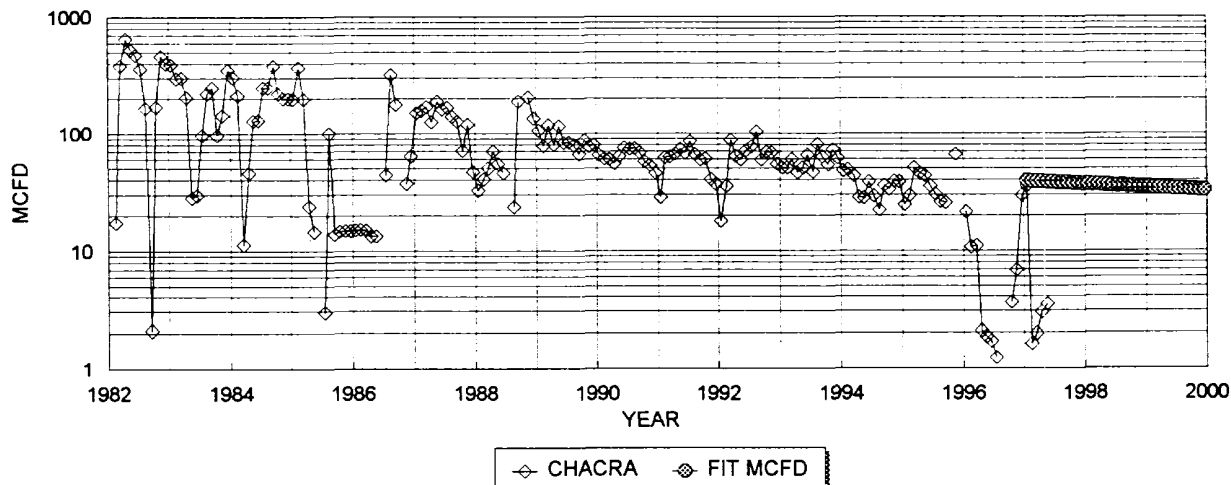

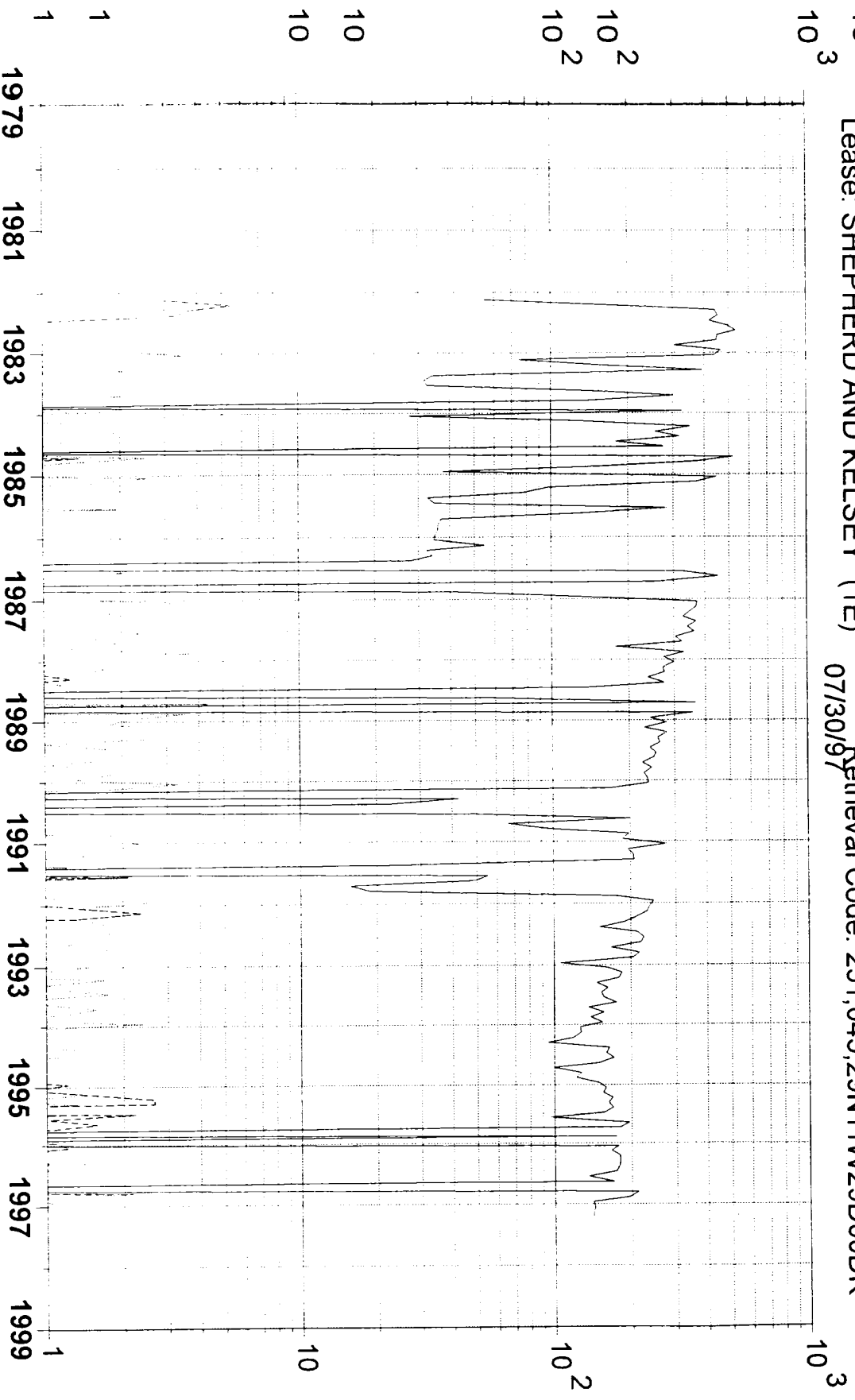
GAS ALLOCATION BASED ON PROJECTED 1997 RATES

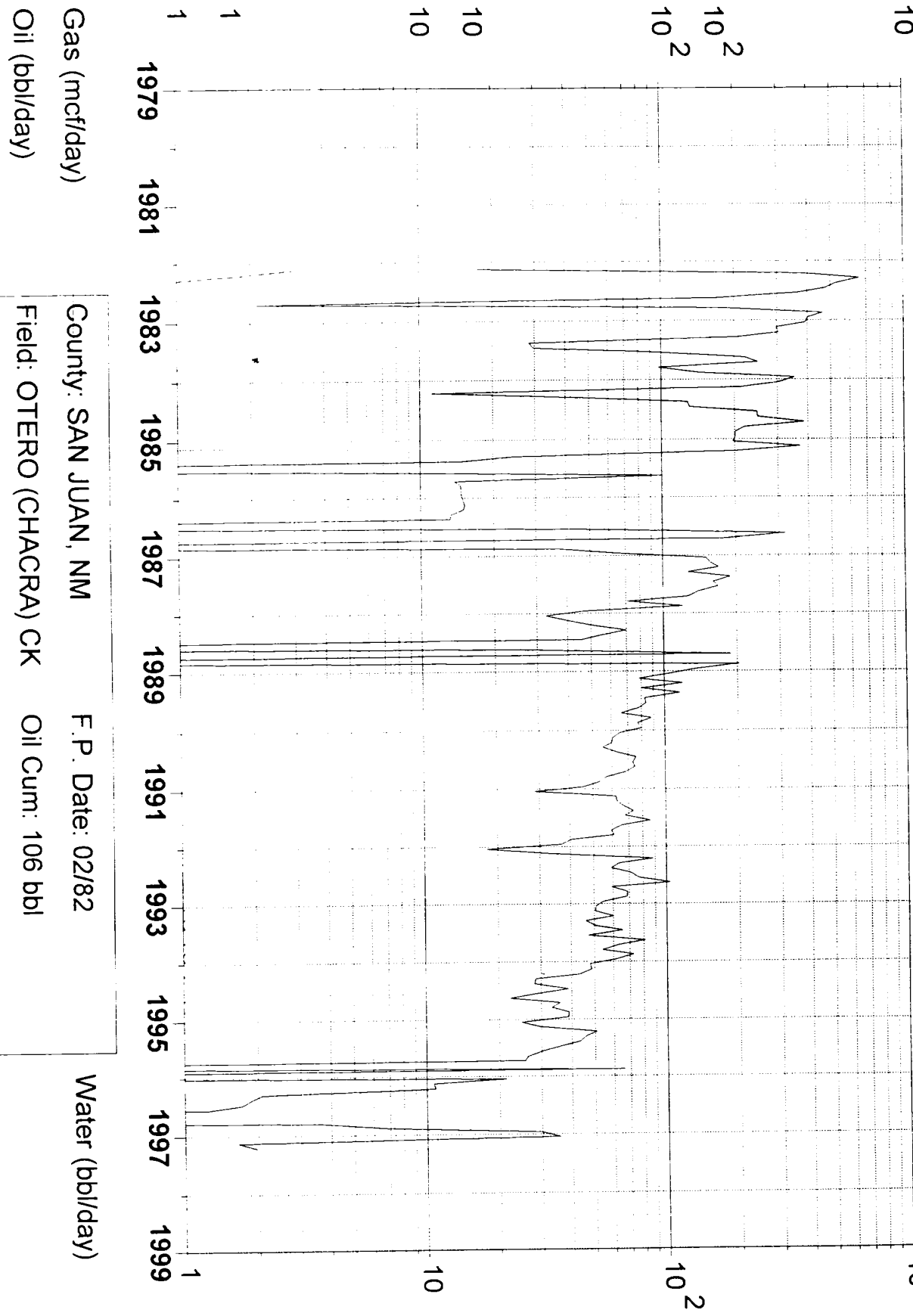

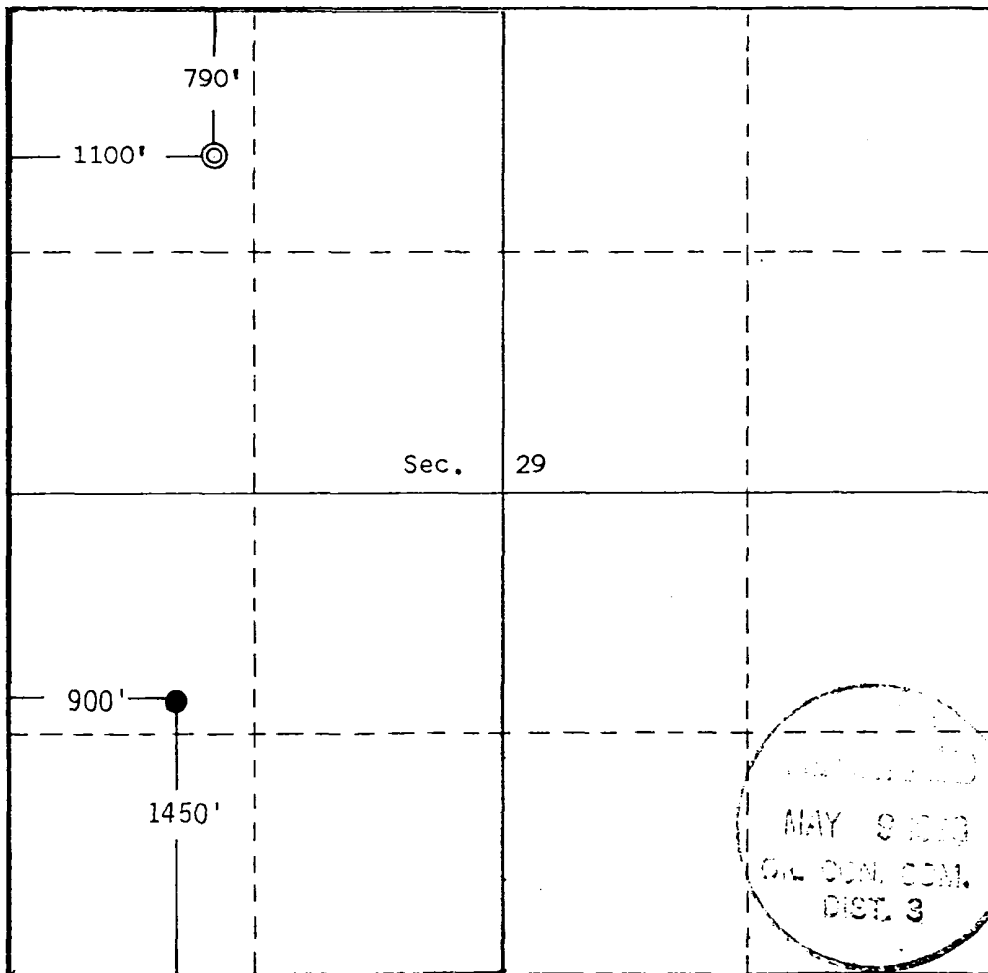

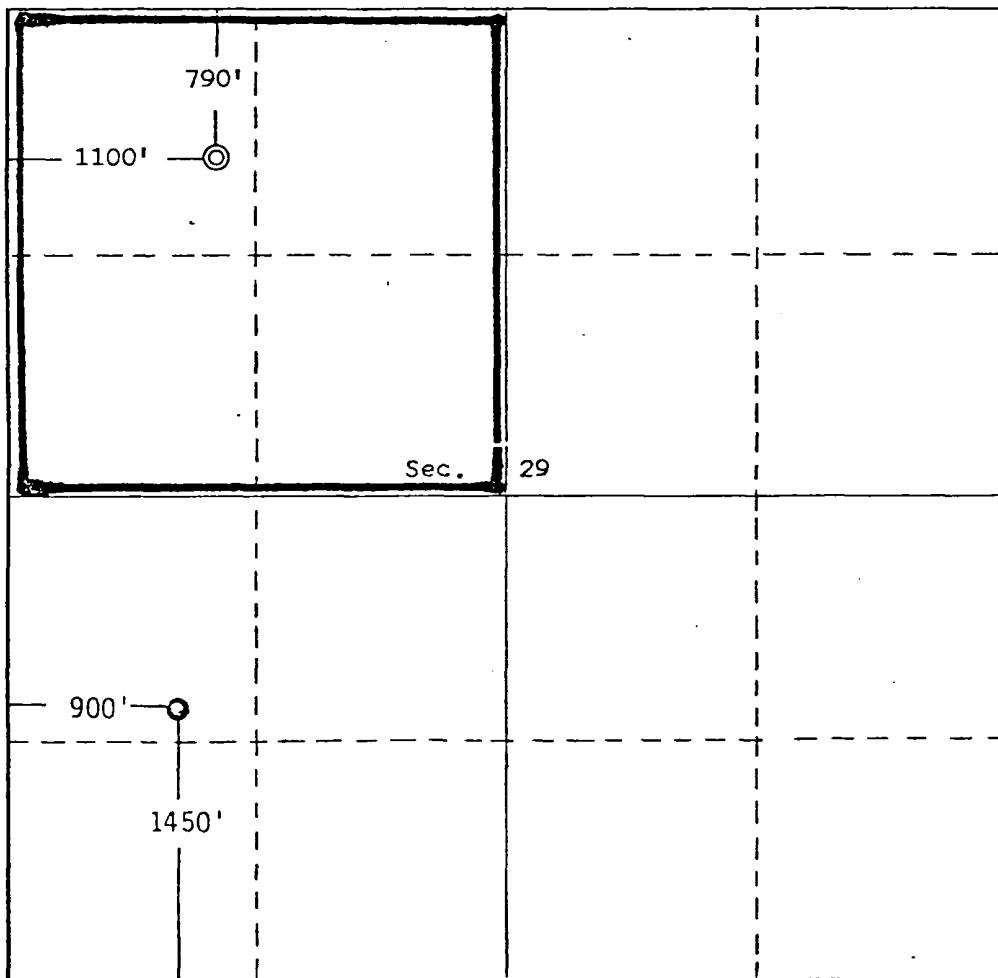
