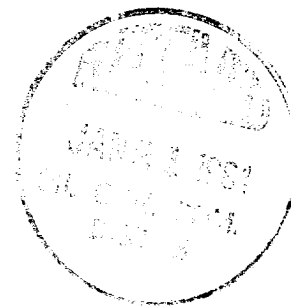

Completion operations began on 11-11-80. Total depth of the well is 6480', and plug back depth is 6451'. Perforated intervals from 6370 to 6392 with 4 spf, a total of 88, .38" holes. Perforated interval 6167-78, 6225-70, 6290-99 with 2 spf, a total of 130, .38" holes. Sand water fraced with 101,000 gallons of frac fluid and 328,000# of 20-40 sand.

Landed 2 3/8" tubing at 6397'. Swabbed the well and released the rig on 11-21-80.
