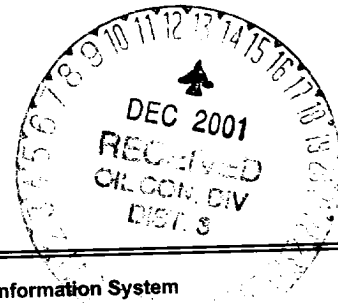

- 1) POH w/dual tubing strings.
- 2) Set plug in Model D packer @ 4,500'.
- 3) Squeeze MV perfs from 4,070' - 4,308' with 200 sx.
- 4) Drill out squeeze. Pressure test. Re-squeeze if necessary.
- 5) Drill out packer and run 2-3/8" tubing.
