the Division in writing of the exact time the test is to be commenced. Offset operators shall also be so notified.

3. The packer leakage test shall commence when both zones of the dual completion are shut-in for

4. For Flow Test No. 1, one zone of the dual communication shall be produced the normal rate of stabilized, provided however, that they need not remain shut-in more than seven days.

of a gas well and for 24 hours in the case of an oil well. Note: if, on an initial packer leakage test, a

gas well is being flowed to the atmosphere due to the lack of a pipeline connection the flow period shall be three hours.

5. Following completion of flow Test No. 1, the well shall again be shut-in, in accordance with

Paragraph 3 above.

1. Flow Test No. 2 shall be conducted even though no leak was indicated during flow Test No. 1.
