10/6/82 - Fraced bottom Chacra perfs (2747-56) with 24,000# of 10/20 sand and 175,752 SCF of CO₂. Ave IR 4.5. Ave Treating Press. 3100# ISIP 1500# 15 min. SIP 1500#. Blew well until 7 PM. Put well back on line.
