This sundry amends the sundry dated 3-2-83. We set 7" liner from 3228' to 5270' and cemented with 462 cu ft (300 sx) of class B neat cement containing 50:50 poz, 6% gel, 2# med tuf plug/sx and .8% FLA. Tailed in with 118 cu ft (100 sx) of class B neat cement. No cement to surface.

We then set 4-1/2" liner from 5040' to 5675' and cemented with 190 sx (224 cu ft) of class B neat cement. Located cement top at 5663'.
