Union Texas Petroleum wishes to advise that this well was spud at 10:00 AM, 4/2/87. A 9-7/8" hole was drilled to 314' KB. Run 7-5/8", 6.4#, K-55 casing to 314' KB, cementing to surface with 120 sx (142 cu.ft.) C1 "B" cement containing 2% CaCl2 and 1/4# flocele/sk. Circulate 6 bbls (34 cu.ft.) of cement to surface. Nipple up BOP and test to 600 psi. Drill 6-3/4" hole out of surface.
