NOTE: This sundry is a continuation of a previous sundry dated 4/28/87.

Pressure tested squeeze holes and lost 300 psi in 5 minutes. Spotted 24 cf Class B Portland from 1201' - 1303'. Revved out 2 barrels of cement and squeezed cement into perfs. Pressure tested and held 2000 psi for 10 minutes. Drilled out 40' of cement. Pressure tested squeeze holes to 1250 psi for 30 minutes. Drilled out cast iron bridgeplug and pushed to 6271'. Landed 2-3/8" short string of tubing at 5654'. Landed 2-3/8" long string of tubing at 6224'. Ran pump and rods. Released the rig on 4/30/87.
