TOOH.Perf'd Fruitland @ 1003'-05', 997'-1001', 984'-86', 962'-66', and 952'-54' w/1 JSPF. TIH w/2 3/8" tubing to 988'. ND BOP, NU wellhead.
- 7-20-85: Frac'd down casing and tubing at 20 BPM w/ 70 Q Foam w/10-20 sand. Screened out with 36,000 gals of foam and 28,000# sand in formation. Reversed tubing clean w/N2. Flowed back frac.
- 7-21-85: Well flowing dry gas at 1027 MCFD thru 3/8" choke nipple. SI well for build-up.
- 7-31-85: SITP-402 psi, SICP-402 psi. Opened well up for 3 hrs thru 3/4" choke nipple. Final FTP-174, 2697 MCFD. SI well waiting on pipeline.
