Under the provisions of Rule 111 (C) and (D), Amoco Production Company made application to the New Mexico Oil Conservation Division on March 8, 1985, for permission to directionally drill and complete for production three wells listed on the enclosed Attachment "A"...

The Division Director Finds That:

- (1) The application has been duly filed under the provisions of Rule 111 (D) of the Division Rules and Regulations;
- (2) Satisfactory information has been provided that all offset operators have been duly notified;
- (3) The applicant, Amoco Production Company, is the owner and operator of said wells, the unorthodox surface location and orthodox bottomhole locations of which are listed on said Attachment "A".
- (4) These wells were previously staked to be orthodox for gas spacing but the wells were reevaluated as qualifying for oil spacing. The surface locations have already been approved archaeologically by the B.I.A. and topographically by the B.L.M. The deviations are being made to remain orthodox for the oil spacing requirements and to satisfy the requirements of the B.I.A. and the B.L.M.
