Top of cement @ 800'.

12-13-85 TD 6855'. Ran 166 jts. 4 1/2", 10.5 & 11.6#'s, J-55 & K-55 casing 6843' set @ 6855'. Float collar set at 6848'. Cmt'd w/143 sks class B, 8% gel, 1/4# cu ft fine Gilsonite/sk, 0.4% HR-7 (311 cu ft), followed by 100 class B, 1/4# fine tuf-plug/sk 0.4% HR-7 (118 cu ft). WOC 18 hrs. Top of cement set @ 3700'.
