Devon Energy proposes to move in a 24-hour coal cavitation rig and remove fish and 5 1/2" liner. Clean out, under ream to 11" diameter and re-cavitate the open hole Fruitland Coal interval. The well will not be deepen. A small lined reserved pit and blow pit will be installed on the pre-existing well pad. At the end of the recavitation process, a 5 1/2" pre-drilled liner with a grade rating of P-110 and a weight of 23 #/ft will be installed across the open hole interval and set in the 7 inch casing with a liner hanger assembly.
