Circulated 1/2 bbl of cement to surface. WOC 8 hrs. NU BOP. Tested casing and BOP's to 1000 psi. Drld 6 1/4" hole to 1740'. TOOH. Ran DIL-SFL, FDC-CNL and Microlog. Ran 42 jts 4 1/2" 10.5# K-55 to 1733'. Mix and pumped 195 sx (255 ft) 50/50 pozmix w/2% gel, 10% salt, 1/4#/sx Flocele followed by 65 sxs (74 ft) 'G' w/0.5% fluid loss additive, 0.4% turbulence inducer, 0.2% fluid loss additive, and 0.25% chemical extender. Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
