Devon Energy proposes to move in a coal cavitation rig and clean out, under ream and re-cavitate the open hole Fruitland Coal interval. The well will not be deepened. The end of the re-cavitation process, a 5 1/2" pre-drilled liner will be installed across the open hole interval and set in the 7 inch casing with a liner hanger assembly.
