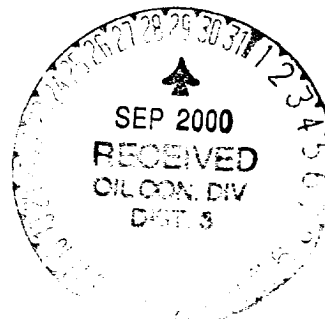

Re-cavitation operations commenced on 8-14-00 and ended on 9-11-00. Pressure tested 7" casing before operations began. The 5-1/2" uncemented, pre-perforated liner was installed. Top of liner hanger at 3568'. Bottom of liner bit shoe at 3849'. 2-3/8", 4.7#, J-55 tubing set at 3819'.
