Duane Spencer gave verbal approval to extend the testing period on additional 30 days past the normal 30 days on January 7, 1991. His verbal approval was obtained conditioned upon BHP documenting it in writing and that BHP would not vent more than the maximum of 50 MMCF during the entire testing period.

Request approval to vent gas from the subject well for a total of 60 days instead of the normal 30 days allowed in NTL-4A.

The additional 30 days are necessary to recover the completion fluids and still have sufficient time to adequately test the well.

Based on the current average daily production we anticipate the total amount to be vented to be less than 10 MMCF.
