Circ 8 bbl cmt to surface. WOC 5 hours. NUBOP. Test csg & BOP to 1800 psi. Drld 6-1/4" hole to 1645' KB. TOOH. Ran FDC/CNL/GR, DIL/SFL/GR, HRL and Coal logs. Ran 39 jts 4-1/2" 10.5# J-55 ST&C csg and landed @ 1633' KB. Mixed and pumped 150 sx (189 ft³) 50/50 Poz w/2% gel + 10% salt + 1/4 pps Cello-seal, followed by 60 sx (69 ft³) Class "B" w/1.2% CF-18 fluid loss additive. Circ 1 bbl to surface. Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
