

DRILLING

1. There was no drilling or completion activity in the Central Cha Cha Unit during 1995.
2. A 5700' Gallup development well, the Central Cha Cha Unit No. 8, is planned at a legal location in the SE/4 SE/4 of Section 31, T29N, R13W. The original APD for drilling was approved on 5-16-89. The APD was resubmitted 8/18/93. APD approval pending BLM on-site inspection.

WELL WORKOVER

1. Central Cha Cha #5 - a sundry was submitted to the BLM 10/12/95 (approved 10/16/95) cancelling plans to return to production or convert to injection and requesting long-term shut-in. A packer will be run and casing pressure tested, per agreement with Steve Mason and Wayne Townsend of the BLM.

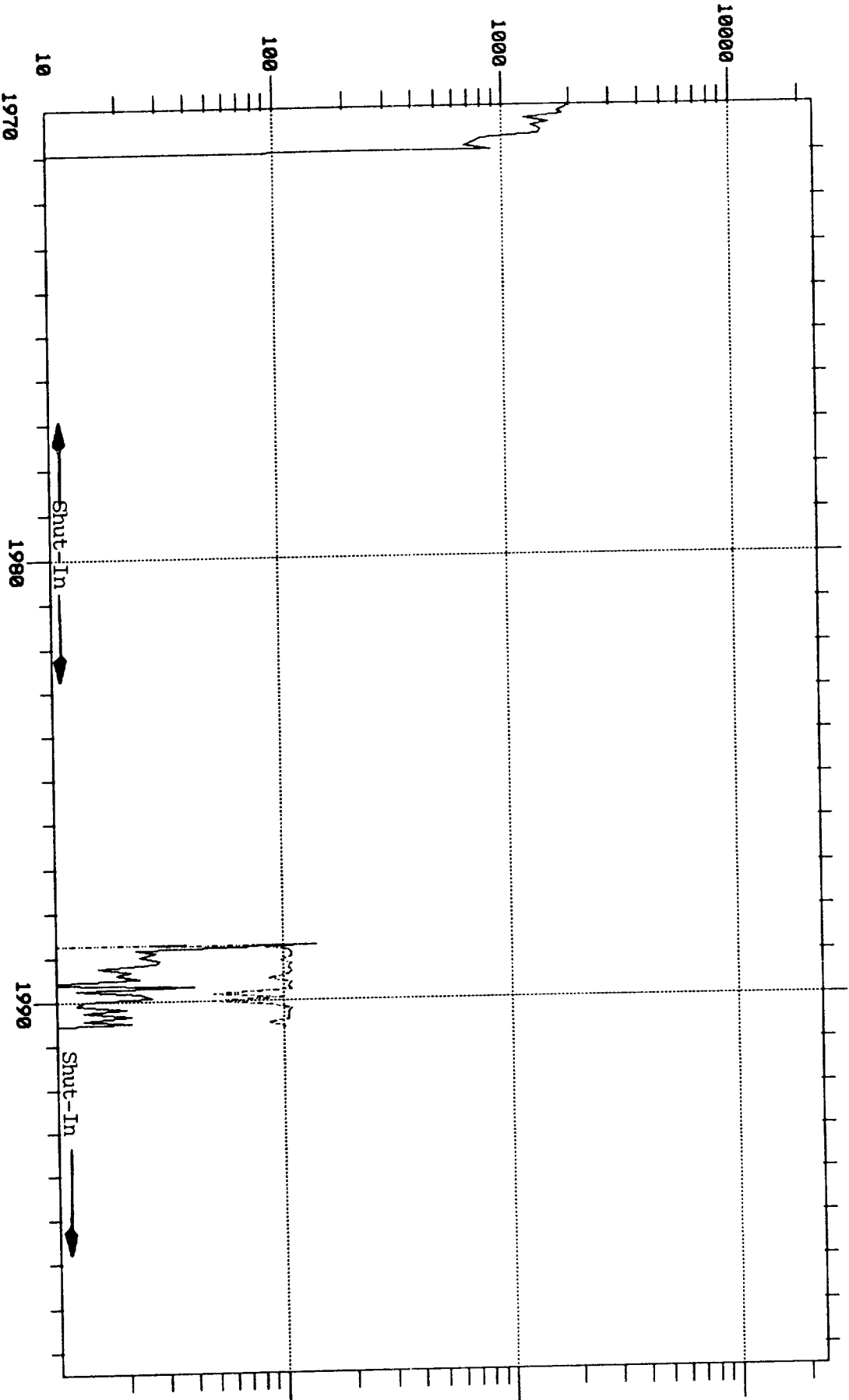
